The Board is pleased to announce that, at the AGM of the Company held on 10 May 2017, all the resolutions as set out in the AGM Notice were duly approved by its Shareholders by way of poll.

The board of directors (the “**Board**”) of Hong Kong International Construction Investment Management Group Co., Limited (the “**Company**”) is pleased to announce that, at the annual general meeting of the Company (the “**AGM**”) held on 10 May 2017, all the resolutions as set out in the notice of the AGM dated 3 April 2017 (the “**AGM Notice**”) were approved by the shareholders of the Company (“**Shareholders**”) by way of poll.

Tricor Tengis Limited, the Company’s branch share registrar in Hong Kong, acted as the scrutineer for the vote-taking at the AGM.

There were no Shares entitling the Shareholders to attend and abstain from voting in favour of the resolutions at the AGM and there were no Shareholders who/which were required under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (“**Stock Exchange**”) to abstain from voting on the resolutions at the AGM. No parties had stated their intention in the circular of the Company dated 3 April 2017 to vote against or to abstain from voting on any of the resolutions at the AGM.
